The National Commission for Protection of Child Rights (NCPCR) is a statutory body constituted under CPCRA Act, 2005 with a mandate to ensure that all laws, policies, programmes and administrative mechanisms are in consonance with the Child Rights perspective as enshrined in the Constitution of India. As per Commissions for Protection of Child Rights (CPCRA) Act, 2005, NCPCR is mandated to monitor laws related to rights of the child, review policies and procedure of the governments and give recommendations for their effective implementation. Specifically, Section 13 (1) (b) of the CPCRA Act 2005 embeds the Commission to spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other means.

2. The Commission has prepared a Manual on Safety and Security of Children in Schools. It is a comprehensive Manual developed by compiling the existing guidelines from different Ministries/Departments/Institutions/Organizations pertaining to safety of children. Realizing the criticality of safety and security of every child, "Guidelines on School Safety and Security" has also been prepared by Ministry of Education (MoE) for fixing the accountability in the matter of safety of children studying in all schools including private schools. For wider dissemination of the Guidelines and Manual, the IEC material has been developed in form of short films/videos for dissemination and further creating awareness among various stakeholders (including children, their parents, schools & other stakeholders) regarding safety of children in schools.

You are requested to issue directions for disseminating the videos among the concerned stakeholders such as District Education officer, Block Education officers, Block Resource Centre Coordinators, Cluster Resource Centre Coordinators, principals teachers & school administration of both private and Govt schools; parents, children etc. The Commission will share the English translated version of the said material in the due course and will also extend its support to the States whichever is willing to translate the material in their State/regional language.
