Whereas, CWP No. 5163/2012 G titled as Rakesh Kaith & others versus State of HP has been disposed of by the Hon; ble High Court on 07.11.2012 with 4954/2012 titled as Madan Lal & others and connected matters with following directions:-

"Therefore, these writ petitions are disposed of with a direction to the Director Higher Education to issue appropriate instruction, if not already issued, within a month from today, to see that the Para Teachers are paid same emoluments as are given to the contract teachers in the respective categories w.e.f. 1.4.2007. In any of these cases, the para teachers have not been paid the vacation salary, the eligible vacation salary shall also be paid to them within a period of three months from the date of production of a copy of this judgement by the petitioner concerned before the competent authority."

And whereas, after receiving these directions from the Hon'ble Court, comprehensive instructions have been issued on 07-04-2007 with prior approval of the Finance Department. In view of these directions undersigned has also issued instructions on 26 July, 2014

And whereas, it is a fact that upon the receipt of the directions from the Hon'ble High Court in CWP No. 4954 of 2012 titled as Madan Lal & others and connected matters, department has issued detailed and comprehensive instructions on 26-07-2014 with prior approval of the Finance Department. According to the above directions dated 07-04-2007, Para teachers are entitled to get Rs. 5000+2500=7500/- w.e.f. 1st April 2007 to 31.03.2010 and Rs. 10300+3200= 13500/- after 1st April 2010 without any annual increase.

Now therefore, in view of the facts & circumstances described above, the matter of CWP 4954/2012-F titled as Madan I al and others is hereby disposed of as per directions issued vide letter dated 26-7-2014. Accordingly arrear bill be restricted as per terms of the order dated 26-07-2014 and recovery if any, is also to be made accordingly. All the Principals of Govi. Sr. Sec. Schools/Headmaster Govt. High Schools are also directed to work out whether the Para Teachers are being paid vacation salary according to the departmental instructions dated 26-07-2014 or not.

Hence, the case of the petitioner is hereby considered and disposed of accordingly. The Dy DEE Shimla is directed to process the case accordingly.
