Subject: Writ Petitions (Civil) 618 & 676 of 2013 titled as Antarrashtriya Manav Adhikar Nigraani VS Union of India & Ors.

Sir/Madam,

Your kind attention is drawn towards this Directorate letter of even No. dated 01-05-2017 followed with reminder Letters dated 07-06-2017, 17-07-2017, 26-08-2017, 13-10-2017 and 27-02-2018 vide which you were directed to get filled up the requisite information online on the prescribed format approved by the Hon'ble Supreme Court for the evaluation of Mid Day Meal Programme in respect of every school in compliance of Hon'ble Apex Court order dated 23.03.2017 in Writ Petition (Civil) 618 & 676 of 2013 titled as Antarrashtriya Manav Adhikar Nigraani VS Union of India & Ors. For this purpose a separate link i.e. "Mid Day Meal Scheme Supreme Court Evaluation Form " has already been created by the Department website in order to comply with the abovesaid orders of Hon'ble Apex Court i.e. http://himachal.nic.in/index1.php?lang=1&dpt_id=16&level=2&sublinkid=14191&lid=1535.

In this context, it is apprised that the Hon'ble Apex court is evaluating the Mid Day Meal Programme across the country from time to time and the matter was listed on 1.08.2018 and accordingly the state wise factual status as on 30.06.2018 in this regard has been conveyed by the Hon'ble Apex Court to all states vide order dated 01.08.2018 and as per this order the Hon'ble Apex Court has observed that since the Himachal Pradesh state has almost complied with the orders of Hon'ble Supreme Court dated 23.03.2017 and provided district wise (School wise) information online which is however insufficient and filled casually but the State actively issued circulars since the last order of the Hon'ble Supreme Court for implementation of the Scheme, However, the implementation part yet to be checked because charts have not been updated. It has been further observed by the Hon'ble Apex Court that more than 50% school do not have utensils for children to eat food apart from other shortfall as on 30-6-2018 and hence lagging behind in implementation.

In view of the above, you are therefore directed to issue necessary instructions to all the schools to fill up the online latest and updated status of requisite information on the approved prescribed format by the Hon'ble Apex Court in this regard up to 15.09.2018 to this Department

website separate link in order to comply with the latest order of Hon'ble Supreme Court of India dated 01-08-2018 i.e. <http://himachal.nic.in/index1.php?lang=1&dpt id=16&level=2&sublinkid=14191&lid=1535> . The respective schools have to fill the form properly and completely at school level or get it filled at nearest GSSS/ GHS OR at BEEO office on priority basis in a time bound manner. Non-Compliance of the Hon'ble Apex Court orders will be at your risk and responsibility and would lead to strict action against the erring officers/officials under the rules.

This may be treated as most urgent, time bound, be given personal attention and top priority being Hon'ble Supreme Court order.
