On the subject cited above, it is intimated that the matter regarding change of nomenclature of Shastri to the post of TGT (Sanskrit) was taken up with Government and the following information desired by the Government in the matter:-

- 1) Number of in-service Shastri and LT who possess the equivalent degree of Graduation in their stream with BEd. Qualification.
- 2) Number of Shastri and LT who possess the equivalent degree of Graduation in their stream with B.Ed qualification but they don't have B.Ed. Degree which is essential qualification for the post of TGT.
- 3) Financial implication involved in it.
- 4) Whether there would be requirement of TET if they designated as TGT Sanskrit and TGT (Hindi).
- 5) What would be the parameters to determine their seniority in the TGT cadre.
- 6) What would be the promotional avenues for the TGT (Sanskrit and TGT (Hindi)
- 7) Whether the cadre of the TGT (Sanskrit) and Hindi would be a separate cadre or would be clubbed in TGT cadre.

Therefore, you are directed to send the above information to this Directorate within a week on the receipt of this letter positively, so that the same could be sent to the Government accordingly.
