of letter of Personnel dated, 30.01.2018.

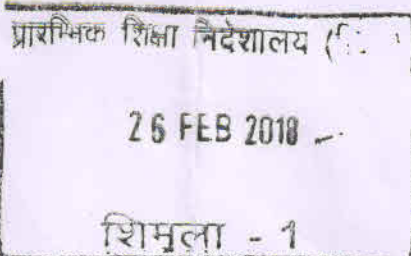
