Renewal applications submitted and forwarded illegally on NSP 2.0
under scholarship meant for minorities.

Sir,

In reference to the letter No 13/9/2015-SS dated 13.12.2016 received from Sh Madhukar D.Naik Deputy Secretary, to the Government of India, Ministry of Minority Affairs, 11th Floor, Pt Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi, through Secretary (SJE) to the Government of Himachal Pradesh, Department of Social Justice & Empowerment (B) Shimla-2 vide letter No SJE-B-F (1)4/2013 dated 10th January 2017 on the subject cited above.

In this context, it is stated that Ministry has observed that there have been instances where the scholarship amount could not be credited through Direct Benefit Transfer(DBT) mode in bank accounts of some students due to bank account status showing Non-active/Non-operational/ Dormat/Transcation limit fixed account etc, therefore you are requested to inform all the students to keep their bank accounts (which have been given for receiving scholarship through NSP 2.0) active. Moreover, it has also been reported that in many cases, bank account validation in PFMS has not been successful as some students are having bank accounts in banks where Core Banking is not active/available

In view of the above, you are requested to inform students of the minority communities who have applied for scholarships under the scholarship schemes of Ministry of Minority Affairs about the matter stated above for doing the needful in the matter immediately to ensure smooth DBT and release of scholarship to them. This is for your kind information and necessary action please.
