Dear Secretary,

Ministry of Health and Family Welfare (MoHFW), Government of India is undertaking the fourth round of Global Youth Tobacco Survey (GYTS-4) which is a school-based survey that collects data on tobacco use among students aged 13-15 years using a standardized methodology. As the name suggest, this school-based survey has been designed to enable the governments to understand the extent of tobacco use among children and to guide the implementation and evaluation of tobacco prevention and control initiatives.

2. The MoH&FW has designated International Institute for Population Sciences (IIPS), Mumbai as a Nodal Agency to conduct GYTS-4 in all the States and Union Territories of the country. IIPS is a Deemed University under the administrative control of MoH&FW, Government of India.

3. The survey will be classroom-based and questionnaire is self-administered in which the students of classes VIII, IX and X and school administrators have to mark appropriate responses anonymously. The survey will be conducted in selected schools in your State/Union Territory by the Field Agencies chosen by IIPS. The Field Agency will approach your office with the list of selected schools to get the support letter. The list of selected Field Agencies for conducting GYTS-4 is enclosed.

4. It will also be necessary to coordinate with your counterpart in the School Education Department in the state. It is requested that all support may be extended to the Field Agencies for carrying out the survey. A letter of support may also be issued from your office or from the School Education Department in your state for assisting in smooth conduct of GYTS-4.

5. Your support and cooperation in implementation of the Global Youth Tobacco Survey will be highly appreciated.
