Sir /Ma'am


As you are aware that State Education Department has developed the Shiksha Sathi Application for capturing observations during school inspection visits conducted by the officers/officials at different levels. These inspections conducted on this App are digitally monitored, compiled and analyzed. The complete data is available on Shiksha Sathi App dashboard for further resolution of issues.

As per the dashboard it is observed that the field functionaries i.e. District, Block and Cluster Level are not conducting the mandated number of visits through Shiksha Sathi App. Mandi, L&S, Bilaspur have not conducted even a single visit till now in the month of October 2019.



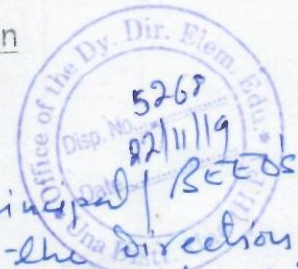


