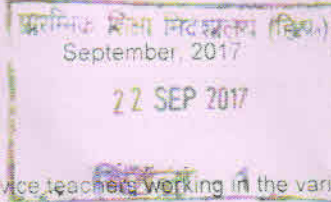

Regarding training of un-trained in-service teachers working in the various
Government /Govt. Aided / Private Schools.

Sir

This is to inform you that as per instructions issued by the Government of India, MHRD, Department of School Education & Literacy, Shastri Bhawan, New Delhi vide D.O. letter No. 17-2/2017-EE 17 dated 3rd August 2017, the matter regarding the training of following categories of in-service teachers teaching elementary classes i.e. 1st to 8th appointed on or after 3rd September 2001 has discussed telephonically with the Director, NIOS, NOIDA, UP on 21st September 2017.-

1. Teachers who are teaching: 1 to 3 classes and do not possess 2 years JBT Diploma or 2 Years Diploma in Elementary Education (D.El.Ed.)
2. Shastri (OT) who do not possess B.Ed. qualification
3. Drawing Teacher (Art & Craft)
4. Physical Education Teacher (who do not possess B.P.Ed. qualification)
5. Language teacher (who do not possess B.Ed. qualification)
6. Urdu Teacher
7. Punjabi Teacher
8. Craft Teacher
9. Home Science Teacher
10. Computer Teacher
11. Any other categories.

During the discussion, he apprised that the above said categories of in-service teachers who are teaching elementary classes fall in the categories of untrained in-service teachers and they have to undergo for 2 years online D.El.Ed. Course through NIOS.

In view of the above, all such categories of teachers appointed after 3rd September 2001 to till 10th August 2017 (which is the date of Gazette Notification of amendment in RTE Act 2009 can apply for this D.El.Ed. course) should register themselves for the above said course on or before 30th September, 2017 on NIOS website i.e. www.nios.ac.in or dled.nios.ac.in.

Apart from above, it has also been discussed that those teachers who are having B.Ed. qualification and teaching primary classes i.e. 1st to 5th should have to undergo for 2 years online D.El.Ed. course through NIOS, which is very strictly to be notified by the Government of India / National Institute of Open Schooling (NIOS), NOIDA, UP.

It is also mandatory to all the above said categories of teachers who have less than 50% and 45% marks (general & reserved categories respectively) in 10+2 or its equivalent to improve their percentage through NIOS before 31st March, 2019. Those teachers who have not attained 10+2 or its equivalent qualification have to register themselves for the same through NIOS online registration and should complete this qualification before, 31st March, 2019.

In view of the above you are therefore, requested to issue necessary instruction to all the concerned except who are having B.Ed qualification to register themselves for D.El Ed. Course through NIOs at NIOS website before 30th September, 2017 positively

It may also be informed to all the above said categories of teachers of Government / Govt. Aided / Private Schools of your District that if they do not possess the requisite qualification before 31st March, 2019, then they would not be allowed to continue in-service from 1st April, 2019 and procedure for dismissal of their services shall be initiated against such teachers


