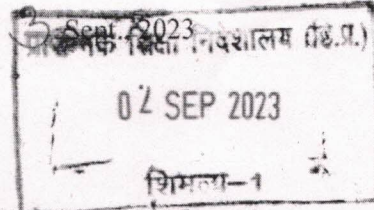

Ex-Petition No. 86/2023 in CWP No. 342/2021 titled as Yashwant Singh and Ors V/S State (Regarding Regularization from back date i.e. w.e.f. 01.04.2018 in r/o PTA Teachers).

It is to inform that the TGTs and C&Vs teachers, who were engaged on PTA(GIA) basis and have been regularized in compliance to the Govt. letter dated 05.08.2020, have filed petitions in the Hon'ble High Court to allow them benefit of regularization w.e.f. 01.04.2018. The Hon'ble High Court has disposed of/decided all such petitions on the analogy of judgement passed on 31.08.2022 in CWP No.342/2021 titled as Yashwant Singh & ors V/s State and allowed the benefit of regularization w.e.f. 01.04.2018 with consequential benefits. The petitioners have now started to file Execution petition for the implementation of the decision passed in various cases.

It is further informed that the Government vide letter No.EDUA-E005/4/2023-EDU-A dated 02.09.2023 has conveyed the approval to regularize the services of the petitioners in CWP No.342/2021 and clubbed petitions (in this CWP and in Execution Petition No.86/2023) w.e.f. 01.04.2018 instead of 05.08.2020.

You are therefore requested to implement the judgement/orders dated 31.08.2022 of the Hon'ble High Court of H.P. in CWP No. 342/2021 (and other clubbed matters) only for petitioners. The consequential benefits to the petitioners will be released as per the policy of State Government for all its existing employees.
