NOTIFICATION

The Governor of Himachal Pradesh is pleased to declare 9th November, 2017 (Thursday) as a Gazetted Holiday in Himachal Pradesh on account of General Election of 68 H.P. Vidhan Sabha constituencies to enable the employees working in all Government Offices/Boards/Corporations/Educational Institutions and Industrial Establishments situated in Himachal Pradesh to exercise their right to franchise. This will also be a paid holiday to daily waged employees and also within the meaning of section 25 of Negotiable Instruments Act, 1881.

It is, however clarified that special casual leave may be given to those employees who are working in different places in the State but have right to vote in other constituencies/ places in the Pradesh on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/her vote
