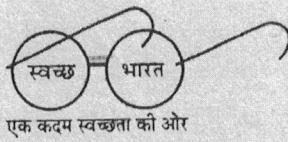

As you are aware, 'Azadi Ka Amrit Mahotsav' is an initiative of the Government of India to celebrate and commemorate 75 years of independence of progressive India and the glorious history of its people, culture and achievements.

2. Hon'ble Prime Minister in the 86th episode of "Mann ki Baat" dated 27th February 2022 has mentioned about creating an environment wherein children from one region may sing songs in the language of other regions to experience "Ek Bharat Shreshtha Bharat" and to celebrate Azadi ka Amrit Mahotsav in a novel way. Hon'ble Prime Minister has urged the youth of the country to make videos of the popular songs of Indian Languages in their own way to introduce the diversity of the country to the new generation.

3. Accordingly, to promote the spirit of Ek Bharat Shreshtha Bharat among the students, the following activities may be undertaken:

i. ii. States/UTs may translate the fundamental duties in different languages and the students participating in the suggested activities/events under the banner of Prime Minister's campaign "Ek Bharat Shreshtha Bharat" being organised at school/State level in hybrid/virtual may read the fundamental duties in different languages

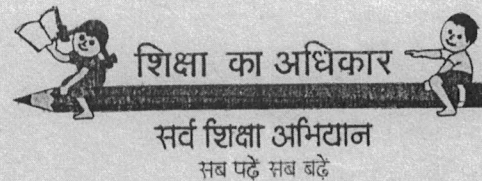
