Subject: Regarding re-constitution of SMC for further three years.

Sir/Madam,

As you are aware that School Management Committees (SMCs) were constituted in the schools of the State with a tenure of three years, vide-Notification No.EDN-C-A (4)-1/2011-Vol.1, dated: 21<sup>st</sup> April, 2014. Lastly the SMCs in the schools were constituted in the year 2014, thus three SMCs have completed 3 years tenure by the end of the year 2016. (In winter closing schools and March, 2017 in summer closing schools).

In view of above, you are directed to get it ensured that all the Govt. Schools & Local Body Schools are issued instructions to reconstitute SMCs in their respective schools within 15 days in the beginning of the academic session as per the RTE rules notified the state government.

Compliance report should be submitted at the earliest to this office.

This may be treated as most urgent and time bound.


