Regarding settling of similar nature cases in order to dispose of the pending litigation matters.

Memo;

It is intimated that the State Government in the year,2011 framed the H.P. State litigation Policy with a view to reduce the litigation , saving avoidable costs on unproductive litigation, reducing avoidable load on judiciary with respect to Government induced litigation and thus realizing the promise of Article 39 A of the Constitution, which obligates the State to promote equal justice and provide free legal aid. In this policy it has clearly been stated that the obligation shall require the State and its agencies to act honestly and fairly in handling the claims and litigation by dealing with claims promptly and not causing unnecessary delay in handling the claims , paying legitimate claims without litigation,including making partial settlements of claims or interim payments, where it is clearly established that at least part of the claim is payable, acting consistently in handling of claims and litigation and endeavouring to avoid litigation wherever possible.It is stated that the adhoc /tenure, restoration of pay scale of Rs.1640-2925 granted on adhoc basis which was reduced to 1500-2640 on regularization, release of vacation salary to the contract/para teachers, benefit of 50% DA merger and benefit of untrained services period cases have attained finality and in such cases benefits have already been released in favour of the petitioners and no reply could be filed in such cases. In order to reduce/avoid the unnecessary litigation, the government has desired to the financial implications and others implication of these cases be please be sent to them within two days positively.

It is therefore,requested that accurate number of all such cases where these benefits have not been released in favour of the similar situated teachers ^{of CW Category} though they are should be ascertained and financial implications involved therein may please be provided at the earliest within three days positively so that the same could be sent to the Government for further necessary action.

It may be extended TOP Priority being Court matter.
