Regarding condition of acquiring minimum educational qualification
as per R&P Rules.

Sir,

In continuation to this Department letter of even number dated 15th June, 2017. I am directed to refer to the subject cited above and to say that the matter regarding acquiring of minimum educational qualification as per R&P Rules, for the respective post(s) by both PTA (GIA) provided teachers, whose services had been taken over or whose services had not been taken over on Contract basis in the State was re-considered at Government level and now it has been decided to extend the period from two years to five years i.e. till 16-08-2021 for acquiring minimum educational qualification as per R&P Rules for the respective post(s), failing which their services will be terminated. In addition to this the State Government has also decided to grant 10 days Medical leave and 10 days Casual leave instead of 08 days for the PTA (GIA) provided teachers only, in a calendar year. The PTA (GIA) provided teachers shall not be entitled for Medical re-imburement. The un-availed Casual leave, Medical leave can be accumulated upto the calendar year and will not be carried forward for the next calendar year.

You are, therefore, requested to take further necessary action in the matter immediately.

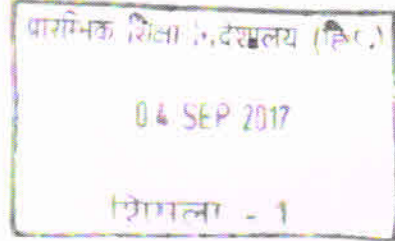
