In continuation of this Department's letter of even number dated 1<sup>st</sup> July, 2020 and in pursuance of Government of India, Ministry of Home Affairs order, No.40-3/2020-DM-1(A), dated 29<sup>th</sup> June, 2020 further circulated by the Ministry of Human Resource, Govt. of India vide their letter No.16-6/2020-UIA, dated 30/06/2020(copy enclosed for ready reference), I am directed to say that schools, colleges, educational and coaching institutions will remain closed till 31.07.2020 & online/distance learning shall continue to be permitted and shall be encouraged.

In order to ensure that students continue to learn and also to ensure the safety of the teachers of educational institutions, it has been decided that teachers be permitted to work from home till 31.07.2020 and they will teach students "on line" through digital/distance learning module as per the past practices followed prior to vacations.
