**OFFICE ORDER**

In pursuance and compliance to the approval conveyed by the Government vide letter No PER(AP)-C-B(2)-1/2018 Dated 11.05.2018 vide Directorate Endst. No EDN-H(Ele-III)-B(2)1-2/2018-(C&V) Regularisation dated 21.05.2013 and based on the verification and recommendations of the screening committee constituted at the Dy. Director Elementary level, the following C&V who were appointed purely on contract basis and posted in GMS/GHS and GSSS in this Distt. against sanctioned vacant posts as per R&P Rules and have completed three year services as on 31.03.2018, are hereby regularized as PET ( Physical Education Teacher ) in the pay band of Rs. 10300-34800/ plus grade pay 3200/- with initial start of Rs 10300+3200/- plus other allowances as admissible from time to time with immediate effect:-

**The above regularization s subject to the fulfillment of requisite terms and conditions as under:-**

1 All the controlling officers/DDOs/Headmasters/Principals are directed to verify all the certificates produced by the candidate concerned from the respective universities on priority basis and necessary entries to this effect be recorded in the service book of the C&V concerned. Any lapse in this regard shall be viewed seriously and would be the personal responsibility of the controlling officer(s).

2 The services of above contract C&V have been regularized as PET (C&V) as they have put in three years service as on 31.3.2018. Period of absence has not be counted towards length of service however; period of un-authorized absence on medical grounds has not been treated as break in period. Before accepting the joining, concerned DDO/Controlling Officer/ Principals/Headmaster are directed to ensure that no departmental enquiry/vigilance case is pending against the C&V whose services has been being regularized. If in any case, it comes to the notice of the authorities at a later stage, then the matter may be brought to the notice of the Department for immediate necessary action.

3 If the above regularized C&V have been transferred to another institution they will be treated regularized where they are presently working and the Principal/Headmaster concerned will ensure to send regularization order to the concerned institution where they have been transferred.


4 If at any point of time, it is so decided or intended by the Government to ensure that the candidate thus regularized would have to improve qualification or undergo any training or exam under "RTE" or otherwise, the same would be required to be accomplished but the above teachers within the prescribed time else the regularization would automatically stand cancelled without giving any notice. An undertaking to this effect may be obtained from the teacher concerned before accepting his/her joining.



5 The seniority of the contract teacher so regularized shall be on the basis of his/her merit in the selection list as Contract .

**The benefits of regularization are subject to the following terms and conditions:-**


- I) The post is temporary but likely to be continued and C&V concerned will be on probation for two years which can be extended for another one year if he/ she does not satisfactorily completes the probation period keeping in-view the work and conduct of the official.
- II) Prior to granting benefits of regularization every C&V shall have to submit the following documents/undertaking to their controlling /DDO:-
  - i) That the regularized C&V should be medically fit for the post being considered for Medical Officer/Medical Officer of the III aqua/area concerned at the time of his/her joining. The regularization shall be subject to the verification of character and antecedents of the candidate by the Head of the Institution.
  - ii) The regularized contract teacher shall be liable to be posted anywhere in the Distt.
  - iii) The regularized contract C&V shall have to submit a declaration to the effect that if married, he/she has only one spouse living. The women teacher will declare that she has not married to a person having another living wife.
  - iv) The regularized contract Teacher C&V will have to make an Oath of allegiance/faithfulness to the Constitution of India.
  - v) The regularized C&V belonging to SC/ST/OBC category etc. will furnish the parental certificate on the prescribed format issued by the competent authority.
  - vi) In case, the credential of the candidate and any of the certificates/documents produced by him/her are found false/wrong, at any stage, his/her service are liable to be terminated.
  - vii) The contract teacher so regularized shall have to serve in the difficult area for a minimum period of five years.
  - viii) That candidate who is being regularized as C&V will have to ensure that he/she has acquired complete knowledge of the latest CCS/conduct rules within a fortnight and submit an undertaking to this effect in writing to his/her head of office/school.
  - ix) The concerned candidate shall have to produce attested copies of her/his academic/professional qualification/domicile/date of birth certificates etc.
  - x) The concerned candidate shall furnish a declaration to the effect that she is not a dismissed employee of any Govt/Semi Govt. Department/Organization. She will have give in writing whether she was ever convicted by the competent court of law and if so, the particulars of the offence and punishment be stated. Failing to disclose the facts, she will render her self liable to be removed from service without any notice as and when the factual facts come to light. The candidate concerned shall have to produce the certificate of her being a citizen of India.
  - xi) The candidate shall have to produce the bonafide Himachali certificate issued by the competent authority.
