I am directed to inform that the Right to Education (RTE) Act, 2009 makes it obligatory for the Government to provide free and compulsory elementary education (classes I to VIII) to each and every child. Accordingly only students studying in classes IX and X are covered under the Pre-Matric Scholarship Scheme of Ministry of Social Justice & Empowerment and Ministry of Tribal Affairs. It has been decided in this Ministry also to award Scholarships to the students of **Classes IX and X only**, under the Pre-Matric Scholarship Scheme, during the year 2022-23.

2. In this regard, a NOTICE has already been uploaded on National Scholarship Portal (copy enclosed). In addition, SMSs are also being sent to all INOs/DNOs and SNOs with the advice to do the verification accordingly.
3. It is requested that the application verifying authorities at L-1 and L-2 levels may be directed to verify only the applications received from the students of Classes IX and X, under the Pre-Matric Scholarship Scheme.
4. This issues with the approval of the Competent Authority.
