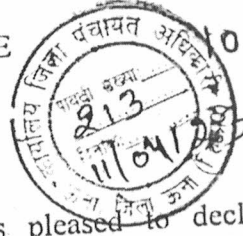

The Governor, Himachal Pradesh is pleased to declare 02.05.2023 (Tuesday) as a "Public Holiday" (in case poll is held) in the area of Panchayati Raj Institutions of the State By Elections to be held to fill-up the casual vacancies.

All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments situated in the Himachal Pradesh under Industrial Disputes Act and shops will remain closed on the said date in the areas of above concerned Institutions where By Election for PRIs are scheduled to be held. This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in concerned institutions (where the By Election of PRIs are scheduled to be held) on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/her vote.


