

(2) In case of contract teachers, if stay is more than one year and stands condoned and relaxation in contractual policy has been accorded, the transfer orders may be implemented , otherwise cases may be referred back with complete feasibility report .

(3) While regulating/implementing the transfer of teachers, the norms and standards for providing teachers in a school as contained under Sr. No.1(a) in the schedule of RTE Act 2009 be complied with strictly. In case of any violation of these instructions you will be entirely responsible .
