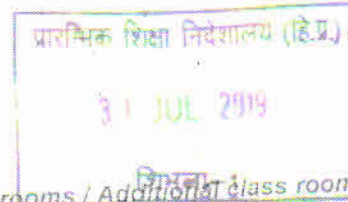

32.


