Subject:- Clarification regarding claiming of salary of PTA Contract Teachers.
Sir,

In continuation to this Directorate letter of even no. Dated 23-09-2017 on the subject cited above.

In this context, it has been observed that the salary of **PTA Contract teachers** working in various Govt. schools in the State is being drawn from head of account **2202-01-101-03-salary SOON, Non-Plan, D.No.8** which is irregular. Whereas the salary of such PTA contract teachers has to be drawn under head of account **2202-01-101-03 Salary SOON, Plan, D.No.8** against the budget provision made by the Department. Similarly, the salary of the PTA Contract Teachers working in BASP, TASP & SCSP under HOA 2202-01-101-03, S00B (Plan) D. No. 15 , HOA 2202-01-796-10, SOON, (Plan) D. No. 31 and HOA 2202-01-789-11-SOON(Plan) D.No.32 respectively should be drawn from the relevant Head of Account.

Therefore, you are again directed to circulate these instructions among the DDO's in your district and direct them strictly to draw the salary of PTA Contract teachers from the relevant head of account as referred above in order to avoid the audit objection/paras and lapse of budget under the said Head of accounts made by the govt. failing which you will be held responsible and action will be taken against the erring officers/officials.
