The above regularization is subject to the fulfillment of requisite terms and conditions as Under:-

1. The concern BEEO are directed to verify all the certificates produced by the candidate on priority basis and necessary entry to this effect be recorded in the service book of the concerned JBT. Any lapse in this regard shall be viewed seriously and would be personal responsibility of the DDO.
2. If at any point of time, it is so decided or intended by the Govt.- to ensure that the candidate thus regularized would have to improve qualification under go any training or exam under RTE or otherwise the same would be required to be accomplished by the above teacher with in the prescribed time else the regularization automatically stand cancel without any notice- An undertaking to this effect may be obtained from the teacher before accepting his/her joining-
3. The post is temporary but likely to be continued and JBTs concerned will be on probation period of two Years. If he/she satisfactorily complete the probation period keeping in view the work and conduct of the officer.
4. The regularized GVU(EGS) should be medically fit for the post being considered for regularization. incumbent should have to submit the medical fitness certificate form the CMO of the area concerned at the time of Joining. The regularization shall be subject to the verification of the character and antecedents of candidates by the DDO.

If the terms and conditions mentioned ^{above are acceptable to} him/her, he /she should report to the Block Elementary Education Officer Concerned along with photocopies of academic / professional certificate / Himachali Bona certificate etc. for getting further orders regarding allow to join in the posted Prry. School from BEEO concern.
