Madam/Sir,

I am directed to inform that Amrit Udyan, Rashtrapati Bhawan will be open to general public from 2nd February to 30th March 2025 to witness Winter Annuals, 2025 from 1000 h to 1800 h (last entry by 1715 h) everyday (except Mondays). Amrit Udyan will also be closed on 5th February, 2025 (due to polling for the Delhi Legislative Assembly), 20th and 21st February, 2025 (due to Visitors' Conference at Rashtrapati Bhawan), and 14th March, 2025 (on account of Holi).

2. The President's Secretariat has desired to increase the outreach to the students of schools and invite them to witness Winter Annuals, 2025 at Amrit Udyan. Facilities for cultural performance by students are available in the open-air theatre within Rashtrapati Bhawan. 
