Sir/Ma'am,

This is to draw your kind attention towards the unfortunate incidence of attack on CRPF Jawans in Jammu and Kashmir that led to death of many Indian Soldiers. This is a time of grief and pain for the entire nation and demands our support for their families in best of our abilities.

The National Commission, as per its functions u/s 13 (d) of CPCRA Act, 2005, requests and recommends to extend relaxation/flexibility for children of the martyred Jawans in the schedule of ongoing/upcoming Board exams and lay down an alternate arrangement for the same. It is also recommended that a circular be issued to all schools to exempt children of the martyred soldiers in yesterday's Pulwama attack from the ongoing/upcoming exams.

For this, an early intervention on your part is requested.
