Regarding Registration/Enrollment under Himachal Health Care Scheme-
HIMCARE.

Sir/Madam,

The Department of Health & Family Welfare, Himachal Pradesh is implementing Himachal Health Care Scheme-HIMCARE for providing cashless treatment coverage to the tune of Rs. 5.00 lakh per year on family floater basis for families which are not covered under Ayushman Bharat on payment of nominal premium. So far, 4.32 lakh families have enrolled themselves under HIMCARE and are availing the benefits.

Amongst other categories, the State Government has provided for a reduced premium for the families of contractual, outsourced, part time & daily wage employees who are working in various Departments and Autonomous bodies/societies/boards/corporations in the State. Such employees need to pay only a premium of Rs. 365/- per year against which their families will be eligible for cashless treatment up to Rs. 5.00 lakh per year for indoor & day care treatment in empanelled health care providers.

The registration/enrollment process under HIMCARE is simple and beneficiaries can register themselves online by visiting www.hpsbys.in and by paying premium after uploading the relevant documents. This process can also be done through the Lok Mitra Kendra/Common Service Centre on payment of extra fee of Rs. 50/- only.

The registration/enrollment process under HIMCARE is open till 20th June 2019. You are, therefore, requested to issue necessary directions to all concerned so that the contractual, outsourced, part time & daily wage employees working in various establishments of the State can avail benefits of this welfare scheme.


