Subject:- Regarding implementation of Pre-Matric scholarship schemes for students with Disabilities.

Sir,

As you are well aware that the Department of Empowerment of Persons with Disabilities Government of India, New Delhi is implementing the Pre-Matric scholarship Scheme for students with Disabilities for class IX & X.

In this context, it is stated that the scholarship for Pre-Matric is implemented through the National Scholarship Portal (NSP) (WWW.Scholarships.gov.in). The registration of the students has been started from 1st June 2017 on the portal. The details of the scheme is also available on the website of the Department Govt. Of India (www.disabilityaffairs.gov.in). After the applicant submits on-line application on the portal, the school/institute are required to verify the application on-line. The application of the scholarship schemes on-boarded on the NSP are received on-line. The applications of the scholarship schemes on-boarded on the NSP are received by the Department of Disability affairs. The last date of applying on-line on the portal for Pre-Matric is 30th September 2017 and the last date for renewal candidates is 31st July 2017. This is a centrally sponsored scheme the entire amount of scholarship is borne by the Government of India (DEPwD). The payment of the scholarship amount is made through Direct Benefit Transfer (DBT) mode to beneficiary's bank account. The role of the District is very crucial in implementation of this scholarship scheme, therefore you are requested to give wide publicity in the scholarship scheme of DEPwD. So that quota allotted to the state can be fully utilized. Therefore you are requested to ensure that all applications from your district for the above mentioned scholarship schemes (**both new and renewal candidates**) should be verified on-line by the concerned Principal well before the stipulated dates as mentioned above.

This may be treated as most urgent and time bound.
