In continuation of this Directorate letter of even No: dated 10-08-2015 vide which detailed Guidelines were issued to all the DDEEs and BEEOs on food safety and hygiene for School Level Kitchen under Mid Day Meal scheme prescribed by the Government of India ,MHRD , New Delhi for implementing the same at school level. In this context, these guidelines are once again circulated to your office for further circulating the same to all the schools functioning under your jurisdiction in a time bound manner and also ensure periodic inspections of all schools so that these instructions are strictly adhered to. Apart from above, the Department of Elementary Education has also issued some separate instructions regarding food safety and hygiene to your office from time to time which are also being enclosed for circulating these instructions to all schools for compliance.

In view of the above, you are therefore directed to issue all these enclosed guidelines and instructions regarding Guidelines on food safety and Hygiene for School Level Kitchen under Mid Day Meal scheme for implementation and strict compliance at school level and ensure periodic inspections of all schools accordingly.

In this regard, it is pertinent to mention here that all the Mid Day Meal incharge and Cook cum Helpers may also be directed and advised that before preparing the meals in the schools under Mid Day Meal all the cooking utensils as well as equipments especially the whistle and safety valve of cookers be properly checked and LPG cylinders and regulators may also be properly be switched off after preparing the meals in order to avoid any untoward incidents under Mid Day Meal Scheme at school level.
