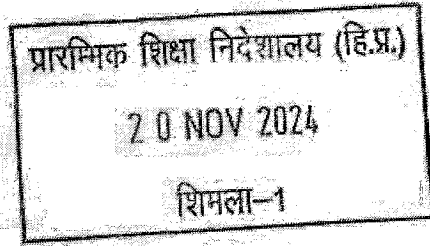

However, in the meantime you are requested to send the name & class wise detail of students who are not having Aadhar till date on the enclosed format (Annexure-I) within week to this office, so that the matter could be processed further accordingly in time.


