

**EXECUTION PETITION UNDER PART-C, RULE 16(1) OF H.P HIGH. WRIT JURISDICTION RULES,1997 ON BEHALF OF THE PETITIONERS FOR EXECUTION OF THE JUDGMENT PASSED BY THIS HON'BLE HIGH COURT ON 04-01-2024 PASSED IN CWPOA NO. 3544/2020, TITLED " NEENA PURI & OTHERS VERSUS STATE & OTHERS".**

**MAY IT PLEASE YOUR LORDSHIP:**

1. That the relevant facts necessary for the purpose of present Execution petition are being given as under.
2. That the present petitioner had filed an CWPOA No-3544/2020 before this Hon'ble court. By way of this Writ Petition, the petitioner praying for the following reliefs:-
  - (i) That the respondents may kindly be directed to treat the contract appointment of the applicant on regular basis against the post of TGT from the date, other similarly situated persons have been offered appointment i.e. 2008 and the respondents may further be directed to

give all the consequential benefits to the applicant in view of the ratio laid down by Hon'ble High Court of Himachal Pradesh vide common judgment in CWP No.1811/2008 titled as Dev Raj & Others Versus State of HP and other connected matters (Annexure A-5) which was upheld in LPA No.367/2012 titled as State of HP & Others V/s Smt. Gopi Devi Thakur & Another (Annexure A-7) as well as LPA No.237/2012 titled as State of HP & another versus Manju Bala and other connected matters (Annexure A-8).

- (ii) That the respondents may further be directed to consider the applicants as appointee of the year 2008 and 2009, when the process was initiated and the persons who have been appointed thereafter may kindly be held juniors to the applicant, with all consequential benefits such as: seniority, arrears, increment, interest @ 9% per annum with effect from the date when the same fell due till its actual realization.
