

Subject:- Non implementation of provision regarding reservation of 25% admission of children belonging to weaker section and disadvantaged group in private unaided schools.

As per the section 12 of RTE act 2009 a school specified in sub clauses (iii) and (iv) of clause (n) shall admit in class one to the extent of in least 25% of the strength of that class children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory education till its completion.

Further the school shall be reimbursed expenditure so incurred by it to the extent of per child expenditure incurred by the state ,or the actual amount charged from the child, whichever is less.

Notification of Government of Himachal Pradesh Department of Education no. EDN-C-A(3)-3/2013-Vol.-I-L dated 06-06-2015 provides for 25% admissions of children belonging to weaker section and disadvantaged group in private unadded schools in Himachal Pradesh in accordance with the provisions of RTE Act,2009 under section 12 and Rules thereunder .

Clause 3(b) of the Guidelines for admission of such children envisages that every school shall submit the information in FORM-I after completing the entire process to the Block Elementary Education Officer in case of the Primary school.

During the course of audit it was noticed that above provision has not been implemented and no admission were made in the two test checked Districts (Chamba and Mandi) by the private schools and hence no reimbursement of expenditure was made by the State Govt.
