Scholarship- regarding.

Sir,

With reference to letter No.11014/01/2016-SCD-V dated 9-05-2016 received from of Sh. T.V.A.Ram Director (SCD-V) Director(SCD-V) to the Government of India Ministry of Social Justice & Empowerment, Shastri Bhawan New Delhi -110001 has been received through Additional Chief Secretary (SJE) to the Govt. of Himachal Pradesh vide letter No. SJE -B-F(1)- 4/2013 dated 03-06-16, on the subject cited above.

In this context, it is apprised that this scheme is being implemented by the central Government to the children of those engaged in unclean occupation the instructions have been issued from Ministry of Social Justice & Empowerment Government of India, New Delhi as given below:-

1. The account of the beneficiaries should be opened in Post- offices/ Bank in name of individual beneficiary students. So that the scholarship amount can be directly credited in their accounts. In due course, students should be able to get their money through ATM/Smart Cards.
2. This scheme covers all eligible children of such parents who are engaged in specified unclean occupation irrespective of their religion. The identification of all the eligible beneficiaries has to be occupation based and not on Caste/ Religion basis. This must be ensured that all eligible children are identified and covered as per regulations governing the scheme.
3. The Unique Identification Authority of India (UIDAI) had suggested bank account for crediting the scholarship and beneficiary identification for process of Aadhar numbers.

You are therefore directed to have the above instructions complied with in the interest of the beneficiaries and bring these to the notice of all the heads of institutions for further necessary action in the matter please.
