Subject:- Regarding Fraudulent/Suspicious claimants of scholarships. Renewal applications submitted and forwarded illegally on NSP 2.0 under scholarship meant for minorities.

Sir,

In reference to the letter No 13/9/2016-SS dated 06.12.2016 received from Sh Madhukar D.Naik Deputy Secretary, to the Government of India, Ministry of Minority Affairs, 11<sup>th</sup> Floor, Pt Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi-11003 through Secretary (SJE) to the Government of Himachal Pradesh, Department of Social Justice & Empowerment Shimla-2 vide letter No SJE-B-F (1)4/2013 dated 11<sup>th</sup> January 2017 on the subject cited above.

In this context, it is stated that No. of complaints have been received by the Central Government regarding submission of renewal applications on NSP 2.0 by some other individuals (who are not actual beneficiaries) illegally by using beneficiaries application ID and date of birth. Bank A/c No, IFSC code & mobile No have also been changed without the consent of Actual beneficiary. At present these applications stand verified and submitted to Dist level by using login credentials of these institutions illegally.

All the NICs have been directed by the central Government to stop the provision of making changes by users on Portal NICs have further been directed to take necessary action to resolve the problems to enable the genuine applicants to apply for renewal with the existing ID and date of birth on NSP 2.0 for the year 2016-17.

In view of the above, you are requested to issue necessary instructions to encourage the students to seed their bank account with their Aadhaar, as the scholarship amount would get credited into the Aadhaar seeded account as per NSP 2.0 provision and also requested to take other appropriate preventive/ corrective steps at your level so that wrong beneficiaries do not take advantage for renewal status. This is for your kind information and necessary action please.
