The Government of Himachal Pradesh is committed towards a worm free future for the children of Himachal Pradesh. In order to reduce the load of intestinal worms in the state, the Department of Health & Family Welfare with support from Department of Women and Child Development and Department of School Education under Ministry of Human Resource and Development has initiated National Deworming Day (NDD) all over the state where all children from 1-19 years of age were given deworming tablet through the platform of schools and Anganwadi Centres. National Deworming Day, has become one of the successful public health interventions in recent times. We have been able to reach millions of children during February and April 2016 rounds.

Moving further, we need to continue this momentum for National Deworming Day round in 2017 also. This year National Deworming Day will be celebrated on 27th April, 2017 all over the state. A detailed NDD toolkit containing operational Framework, monitoring checklists, FAQs and Factsheets is uploaded on NHM website i.e. www.nrhm.gov.in Concerted efforts from all three departments at State, District and Block Level are required to ensure effective implementation and increased coverage of the programme.

The following steps are suggested to strengthen the coordination amongst the three stakeholder departments for the NDD programme:

- All the key stakeholder departments to coordinate with Department of Health in effective rolling out of NDD.
- The state and district level NDD coordination committees to be chaired by the Principal Secretary (Health) and District Collector respectively.
- School Education and Women and Child Development departments to provide the Department of
 Health with the desired numbers of target age group to cover all children 1-19 years age group
 including private schools, so as to ensure adequate procurement and supply of Albendazole tablets
 and made for conducting NDD.
- 4. All the departments need to put national Deworming Day as one of the agenda in their periodic meetings to reinforce key message for the program and facilitate high coverage.

- 5. Training of functionaries from Education and WCD Departments to be supported by Health Department at State and District Level, while block level training of teachers and Anganwadi workers to be led by respective departments.
- All stakeholder departments to disseminate the IEC material provided by the Department of Health
 to the Schools, Anganwadi's and community as appropriate for increasing program awareness and
 facilitate greater coverage.
- Officials of all stakeholder departments are mandated to undertake field visits for monitoring and supportive supervision on the NDD and mop up day.
- 8. Reporting formats filled by schools and AWCs to be collected by ANMs from Schools and Anganwadi's within the specified timeline.

We request you to issue directives as above to the concerned departments of the state Government for implementing of NDD on 27th April, 2017 and ensuring interdepartmental convergence. We look forward to your support and cooperation for the successful implementation of the programme.
