With reference to the Government letter No. EDN-A-B(6)8005-XI-L dated 24-5-2016 (copy enclosed) vide which the instructions regarding PTA provided teachers were issued to all the Deputy Director of Elementary Education in the Pradesh vide this Directorate endorsement letter No. EDN-H(2)B(2)36/2014-PTA dated 1-7-2014 for further necessary action.

In this context, as per the recommendation of the High Power Committee that all the categories of PTA provided teachers were to be allowed to complete their requisite educational qualification till 16-08-2016 as per R&P rules and no GIA will be given after 16-08-2016. Therefore, you are directed to adhere the instructions of the Government strictly and in case of any laps, the amount will be recovered from the DDO concerned accordingly. Besides this it is further directed that the detailed information of those PTA provided teachers whose services were taken over on contract basis but they did not acquire their requisite qualification as per existing R&P rules till 16-08-2016 may also be provided to this Directorate within seven days on the receipt of this letter positively, so that the further action in the matter could be taken accordingly.
