Subject:- Regarding Pre-Matric scholarship for Students with Disabilities for classes IX & X.
Sir,

In reference to the letter No Nil dated 7.7.2016 received from the Dr. Vinod Aggarwal, Ministry of Social Justice & Empowerment, Department of Persons with Disabilities (Divyangjan) 5th floor, Paryavaran Bhawan CGO Complex, Lodhi Road, New Delhi through Director (S.C.OBC & Minority Affairs)-cum-Joint Commissioner(Disability)H.P. shimla-2 vide letter No.4-1/2013(26)-SOM-Wel(Scholarship)14043-14068 dated 19.7.2016 H.P. on the subject cited above.

In this context, it is stated, that the Department of Empowerment of Persons with Disabilities, Government of India is implementing the scholarship scheme of Pre-Matric for students with more than 40% disabilities. This scholarship will be received on-line only. The registration of the candidates for scholarship will be done on NSP2.0 which is being developed by the National information Centre. The date of opening and closing of registration for scholarship scheme will be announced shortly by the Government of India. A scholarship holder under this scheme will not hold any other scholarship. Not more than two disabled children of the same parents will be entitled to receive benefits of the scheme. You are therefore requested to bring these instructions to the notice of all the Heads of GSSS/GHS/schools recognized by Government or by a centre/ State Board of Secondary of your district necessary compliance and for giving wide publicity in this regard in the daily morning assembly, by displaying a notice on the school notice board in the public domains, Panchayat / municipality offices, Mahila Mandal offices etc, and details of the schemes is also available on the website of Government of india(www.disabilityaffairs.gov.in)

Notice:- Students must select their bank branch details carefully from the drop down list. Thereafter the complete bank account number must be entered correctly. If bank details entered by the students are found incorrect, the scholarship amount will not be transferred through the application is approved for scholarship.
