Subject: Regarding Aadhaar enrolment & Aadhaar seeding of the beneficiaries of the Scholarships Schemes for the implementation of the Direct Benefit Transfer.
Sir,

With reference to the letter No. 5-5/2016-SCD dated 28th July 2016 received from Sh Arvind Kumar, Director, Government of India, Department of Social Justice & Empowerment 6th floor, Shastri Bhawan New Delhi-110001 through Secretary (SJE) to the Government of Himachal Pradesh vide his letter No SJE-A(5)-2/2008- Loose dated 18th August 2016 on the subject cited above.

In this context, it is stated, that the instructions has been issued for pertaining to the Aadhaar Seeding & DBT implementation have been conveyed to states in a time bound manner as given below:-

1 In the review meeting taken by the PMO on 7th July 2016 it has been decided that all payments under scholarship schemes be through DBT and should be made Aadhaar seeded by 30th November, 2016. All individual payments of subsidy and welfare schemes should also be made through DBT by 31st March 2017. It is also mentioned that the timeline for Aadhaar seeding was 31st December 2015 but in the review meeting taken by the PMO the timeline of the Aadhaar seeding has been revised to 30th November, 2016..

2 As progress in achieving this timeline will be closely monitored, you may kindly ensure that necessary directions may be given to achieve these milestones. you are requested to review the progress on a monthly basis.

3 In order to implement the DBT in a smooth & effective way, it is requested that compliance of the instructions may be complied with and expedited to the Department of social justice & Empowerment, Government of India New Delhi..

In view of the above you are directed to direct this direction to All the BEEOs/Headmasters/ Principal under your control to take necessary action in this matter.

This may be treated as most urgent and time bound please.
