OFFICE ORDER

Whereas, this order is being issued for effective implementation of Right To Information Act, 2005 and to enable general public to seek information about the functioning of recognized private schools (Primary & Upper Primary) to the extent of Self declaration made by the schools concerned under the Right To Education Act, 2009 & read with the Right To Education Rules of Himachal Pradesh Govt. Rules 9.

As per the direction of the State Information Commission Majitha House, Shimla-171002 vide letter No. SIC I (A) 0470/2014-15-5292, dated 19.02.2016 and exercise of the powers vested in me as "Public Authority" vide Government of H. P. letter No. EDN-C-B (15) /2003-loose dated October 3, 2005, I hereby declare and designate all the Block Elementary Education Officers in Himachal Pradesh as Public Information Officer for (Primary) private schools under their jurisdictions of respective block and Deputy Director of Elementary Education Officers as Public Information Officers for (Upper Primary) Private Schools under their jurisdiction of respective districts for the effective implementation of provisions of the "Right to Information Act- 2005" with immediate effect. Deputy Directors of Elementary Education of districts concerned will also Act as the 1st Appellate Authority in respect of the private schools (Primary) of their respective districts and Additional Director (Admn) of Elementary Education Department will also Act a 1st. Appellate Authority in respect of the private School (Upper Primary).

And whereas all the Headmasters / Principals of recognized Private Schools (Primary & Upper Primary) will hereafter be equally responsible to implement and comply with all the instructions and provisions relating to Right To Information Act, 2005 & Himachal Pradesh, Right To Information Rules, 2006. This order may also be brought to the notice of the Heads of all Private School in their district for further compliance. List of private schools (Primary & Upper Primary) of their district and name of the PIO along with this order may also be displayed in notice board of their offices & institutions for welfare of the general public.
