Exemption of TGTs(Non-Medical and Medical) from Non-Academic Activities in schools.

Sir,

During previous Board Examination and this year Mock Tests conducted for the preparation of NAS 2024, it has been observed that the performance of the students is comparatively unsatisfactory in subjects of Maths, Science and English. This shows that TGTs teaching these subjects need to put extra efforts to improve the learning outcome of students in these subjects and to enable them to do so, they need to be exempted from all sorts of non-teaching activities.

Therefore, it has been decided that TGTs, Non-Medical & Medical, and Arts be exempted from all types of Non-teaching duties such as Sports and Cultural activities, MDM Incharge and supervision of MDM related works, scholarships and other similar assignments in schools. Additionally, they should not be assigned roles such as maintaining accounts of SMC works, be involved in activities outside of their academic responsibilities so that they may devote full time & focus on teaching. With fewer non-academic activities, these teachers can concentrate on enhancing academic outcomes and offer extra classes for students who require additional support.

Supervision of Non-Academic activities in High Schools and Senior Secondary Schools shall be assigned to Ministerial Staff or Lab Attendant or DPE or C&V teachers. Only in case of non-availability of these options TGTs(Arts) can be as given non-teaching Assignment. However, TGT(NM) and TGT(M) shall be kept free from all these Non-Teaching assignments.

The concerned Heads of the schools are directed to ensure compliance of these instructions immediately and exempt the TGTs particularly TGT(NM) & TGT(M) from Non-Teaching assignments.
