

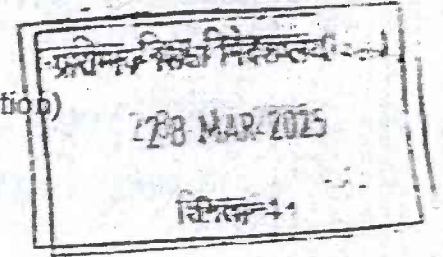


Your kind attention is drawn towards Additional Secretary, Government of India, Ministry of Education, Department of School Education & Literacy, New Delhi D.O. No. 4-2/2017-MDM-1 dated 19th March, 2025 on the subject cited above.

In this regard, as you may be aware that Ministry of Health & Family Welfare conducts Health check-up of enrolled school students of classes 1st to 12th under the Programme Rashtriya Bal Swasthya Karyakram (RBSK) for 30 identified diseases. In addition to this the Ministry of Health & Family Welfare also provides Iron & Folic Acid Supplementation medicine on weekly basis under Anaemia Mukh Bharat & De-worming medicine distribution twice in a year on National De-worming Day in the State. At present Department is capturing data of health check-ups and distribution of medicines including IFA and De-worming for classes 1st to 8th. Now, GOI is seeking data of all enrolled students of classes from 1st to 12th undergone for health check-ups and received medicines of IFA and De worming medicine during 2024-25 on the prescribed format (copy enclosed)

In view of above, you are requested to collect the above data from schools and provide to this Directorate on or before 29.03.2025 on prescribed format so that same could be provided to GOI.




