"OFFICE ORDER"

You are therefore, directed to implement the above transfer(s)/ adjustment(s) orders keeping in view the condition given overleaf. If the implementation of above approval is not administratively feasible, then the case may be referred back immediately giving full detail. (However, PMIS data be updated immediately).

- Note:- (1) In case of regular teachers, if stay is more than one year and stands condoned, the transfer order may be implemented. Otherwise case(s) may be referred back with complete feasibility report.
(2) In case of contract teachers, if stay is more than one year and stands condoned and relaxation in contractual policy has been accorded, the transfer orders may be implemented, otherwise cases may be referred back with complete feasibility report.
(3) While regulating/implementing the transfer of teachers, the norms and standards for providing teachers in a school as contained under Sr. No.1(a) in the schedule of RTE Act 2009 be complied with strictly. In case of any violation of these instructions you will be entirely responsible.



Conditions for transfer(s)/ adjustment(s):-

1. The transfer(s)/ adjustment(s) be implemented as per the policy of transfer of teachers in Education Deptt. Himachal Pradesh notified vide Principal Secretary (Edu.) Letter No. PER (AP-B)E(3) -17/2012 dated 10th July, 2013.
2. It should be ensured that no stay orders has been issued by any Court of Law qua the posts involved in the Transfers/Adjustments.
3. If the teacher has earlier been transferred on administrative grounds/public interest then the case may be referred back for further directions.
4. The teachers under transfer from non – difficult/ Non – tribal area to difficult/ sub- cadre/ tribal area shall move first.
5. The teacher under transfer from difficult /sub – cadre /tribal area shall be relieved only after the joining of his/ her substitute.
6. The teachers working under Contract/G.V.U policy will be considered eligible for transfer against vacancy only after the completion minimum teacher.
7. The teachers on 1st appointment in difficult/ sub-cadre/tribal area will be considered eligible for transfer only after the completion of minimum 5 years tenure.
8. The school must not be left without teacher in any condition.
9. No surplus arrangements/ maladjustment is made.
10. Normal stay/ distance is as per the transfer policy dated 10th July 2013 unless condoned by the competent authority.
11. The recommendation of the general body of the school management committee made on the completion of the academic session are also to be kept in view.
12. If more than one approval has been received for the same station simultaneously than the matter be referred back for further orders.
13. If the approval for transfer has been conveyed on mutual basis, than the mutual consent is confirmed before Implementation.
